- 2. Pennsylvania Electronic Student Transcripts and Records System (PA eSTARS) Presentation by Chris Hyde, Parchment, Inc.

PA eSTARS is a voluntary statewide initiative for the secure & confidential transfer & digital exchange of student records and transcripts. Transcripts can flow and/or transfer through from Pre-K through 20, from K-12 to K-12, high school to college admissions, and transfer from college to college.

PDE received a federal grant to coordinate PA eSTARS and assist colleges by off-setting the implementation fees. All Institutions of Higher Education (IHEs) – include all TAOC institutions – are eligible to participate. IHEs that sign with Parchment by June 30, 2013, will have their implementation fees of \$3,000 covered by the federal grant awarded to PDE. Parchment will waive additional fees for colleges that signs up by December 31, 2012. The combination of the grant and waiver means colleges can try Docufide for the first (up to) 15 months at no cost.

As part of PDE's contract with Parchment, processing fee is reduced to a maximum of \$3.00 per transcript for the life of the contract (3 years). Most of this cost is borne by the high schools, and either absorbed or passed on to the student.

Recent Pennsylvania postsecondary additions to the platform include Drexel University, Temple University, Northampton Community College, Bucks County Community College, Delaware County Community College, and Montgomery County Community College. West Chester University of PA received 7,000 high school transcripts via the system in 2011.

Parchment's eTranscript service is called Docufide. Parchment offers webinars to demonstrate the system. Docufide aligns to the college's business process and based on what works for each institution. Colleges can participate regardless of their current Student Information System. Implementation is simple, requires minimal IT time, and can go-live within a matter of days.

Transcripts are exchanged in manner compliant with FERPA. The system involves multi-layer security procedures. System is a pass-through, meaning data is sent on request and must be retrieved by the receiving institution within 48 hours, otherwise it disappears. Colleges do not upload data to Parchment or PDE. In fact, PDE is not involved in the system at all. Transcripts are sent from the sending college through the Docufide system directly to the receiving college.

Any IHE can receive digital images student transcripts for free. Colleges must subscribe with Parchment to send electronic transcripts and to receive transcripts in a data format compatible with their SIS. "Parchment Discover" is a data tool that allows colleges to analyze data from the system (i.e., demographics of students requesting/sending transcripts).

PA Commission and PASSHE's Office of the Chancellor are assisting PDE and Parchment with outreach. Jill Hans, Deputy Secretary of Postsecondary and Higher Education, sent an email



announcement to all IHE presidents in September. Mary Francis Archey (CCAC) asked if information could be presented to the CC presidents at their next Commission meeting. Lauren agreed to follow up with Diane Bosak.

4. ACTION ITEM: Vote to Approve or Reject August 9, 2012 Meeting Notes

Vote was postponed in order to give TAOC members time to review. Feedback must be submitted

5. TAOC/PA TRAC Maintenance Activities

a. Primary/Secondary Points of Contact for AY12-13

Julie thanked everyone for submitting their updated contact sheets to AcademyOne. TAOC members are responsible for keeping track of their institutional points-of-contact for TAOC/PATRAC activities and notifying PDE immediately of any changes. AcademyOne sent training manuals to all new contacts and offered webinars/one-on-one training for new CEMC users. TAOC members need to follow- up with their contacts and make sure they completed training. If they still need training, contact AcademyOne.

b. Composite Institutional PA TRAC Status Report as of Oct. 23, 2012 – See Appendix B

The variation in the number of course equivalencies is attributed to equivalency synchronizers. If your institution does not currently have a synchronizer, contact Julie Kane ASAP. If you want to have the PATRAC Widget on your website, you need to have an equivalency synchronizer.

- c. Current Activities
 - i. Missing Course Catalog Extracts

Extracts are still needed from Butler County CC, East Stroudsburg University and Northampton CC. AcademyOne is working hard to get the course extracts loaded into the system. Extracts are loaded approximately 1-2 weeks from the date of submission. Institutions that have not yet submitted extracts need to contact Erik Shepski at AcademyOne immediately.

ii. Course Equivalency Management Center (CEMC)

When a new Course Catalog Extract is uploaded to CEMC, the system automatically detects and highlights any change(s) from the previous extract. An email notification then is automatically sent to the other party in the equivalency. The new course extracts uploads means that CEMC users will be receiving notices to evaluate new courses and/or courses that have changed since originally being evaluated for transfer.

For this reason, it is imperative that TAOC members confirm their institutional CEMC contacts have been properly trained to use CEMC, evaluate courses, establish equivalencies, etc. AcademyOne offered three webinars in September for new and existing CEMC users. However, according to AcademyOne, there are a few new CEMC users who did not attend and have not contacted AcademyOne for training.



iii. Importance of Keywords in Degree Program Search Database

At the August 9 meeting, TAOC discussed the limited search capabilities of the Program Search Database accessible via PA TRAC. AcademyOne confirmed the primary cause is the limited use of keywords by submitting institutions.

- Community Colleges and Opt-Ins provide keywords when they upload their degree program information.
- Eric Zeglen from PASSHE's office of the Chancellor provides program information for all of the PASSHE universities. Therefore, PASSHE universities must provide keywords to the Office of the Chancellor in order for them to carry-over into the PA TRAC system. See Eric Zeglen for details.
- iv. Statewide P2P Articulation Database **May 15, 2013** is the deadline to identify articulated associate degrees and parallel bachelor degrees effective Fall 2013.

6. Statewide Program Articulation Agreements

a. Statewide P2P Report

The "P2P Status Report as of Oct. 24 2012" was sent as a separate handout. A more current version (dated Nov. 12, 2012) accompanied the draft October meeting notes and will be posted on PA TRAC. Members are welcome to share the report with their campuses as needed.

PDE needs assistance developing the webpage(s) that explain Statewide Program Articulation to the public. Specifically, PDE needs help with wording, look/feel of the pages, testing the searchable database, etc. Mike Hannan (Edinboro) suggested using a small student focus group.

When conducting a course equivalency search on PA TRAC, Framework courses are noted by "yes" or "no" in a column called "Transfer Framework Course". Unfortunately, Bill Sands (IUP) said there is a misconception that courses tagged "no" do not transfer, which isn't the case; "no" courses simply mean the courses don't qualify for universal transfer under the 30-credit Framework. PDE agreed to look into this and work with AcademyOne to find a better solution.

b. Fall 2012 Compliance

PDE collected Accuracy Verification Statements from all TAOC institutions in August. At that time, 25 of 33 participating institutions were compliant.

- All 5 opt-in institutions are compliant
- Seven of the 14 community colleges are compliant. A majority of the noncompliant colleges expect to be compliant by Spring 2013. (due to need to develop or modify courses, etc.)



- Thirteen of the 14 PASSHE universities are compliant. One university is working on bringing its associate degrees in Business and PK4 into compliance.
- Majority of non-compliant institutions expect to be in compliance by spring 2013

Institutions gave the following reasons for non-compliance:

- Developing new courses to meet agreement requirements
- Program and/or course modifications need to be approved through college governance system
- Program does not meet the Framework requirements included in agreements such as Biology, Computer Science and Mathematics
- College's general education curriculum is not limited to Framework courses
- Current associate degree programs do not meet the approved P2P requirements and have not been modified to meet them

The AVS is now a report feature accessible from directly from the P2P database. When it's time to submit the AVS in January 2013, PDE will email each institution's point of contact for the P2P database with instructions for downloading the AVS *directly from the P2P database* and submitting it to PDE. More details about this process will be provided at the December TAOC meeting.

May 15 is the deadline to identify articulated associate degrees and parallel bachelor degrees effective Fall 2013.

- c. Pending Agreements
 - i. Political Science The Poli Sci PAC has submitted a final draft to PDE for TAOC review. PDE will email TAOC members on Nov. 5 with a link to the agreement and the voting form. Primary members then have until Nov 9, 2012 to cast their votes to approve or reject. (NOTE: Deadline extended via October 31, 2012 email from Julie Kane, due to weather-related closings).Votes to reject must give a reason for rejection. Even if your institution doesn't have the program available you still have to vote. Majority vote (23 votes) is required to approve.
 - ii. Music Julie Kane will get back to you on this in the near future
 - 4-8 Education Joel Geary (PDE) has agreed to assist the 4-8 PAC. PDE is working with Joel to find dates that he can meet with PAC members in Harrisburg.
 - iv. Secondary Education PDE will work with Francie Spigelmyer and get this back up and running

7. Transfer Credit Framework

a. Framework Standards Subcommittee Members - See Appendix C (Revised)


TAOC cannot move any Framework work forward until all subcommittee positions are filled. TAOC policy requires every fully-participating institution appoint a representative to serve on one of the four subcommittees. Several proposed courses are stuck in subcommittee review because membership has changed.

Notify PDE of any committee member changes and new appointments by Tuesday, November 6, 2012. (NOTE: Deadline extended via October 31, 2012 email from Julie Kane, due to weather-related closings.) Subcommittee members should be appointed according to their interests and academic background.



NOTE: Standards Subcommittees are now at capacity. Appendix C reflects recent changes.

b. Process for Expanding the Transfer Credit Framework Titles and Proposing Courses to Subcommittees



At the August meeting, TAOC agreed to use the above process to consider new foundationlevel course titles for the Framework. This is the process that TAOC used originally to develop the Framework.

TAOC members should email suggested Framework course titles, along with course descriptions and any other related information, to Julie Kane by Friday, November 9, 2012. (NOTE: Deadline extended via October 31, 2012 email from Julie Kane, due to weather-related closings).

Suggested titles must be foundation level courses with general titles. Foundation courses are the type of coursework typically completed in the first and second year of any bachelor degree program. PDE has a list of suggested Framework titles already started. That list includes courses proposed by the PACs, the Standards Subcommittees and TAOC members.

After Nov. 9, PDE will forward the list to the Subcommittee chairs for consideration. Recommended course titles will then be forwarded to TAOC for consideration. See above process.

8. DISCUSSION ITEM: Policy Regarding Dispute Resolution Subcommittee

Legislation mandates that TAOC to have a Dispute Resolution Subcommittee (DRS).

• TAOC's policy regarding the committee is found in Appendix D.



• Appendix F shows the membership rotation. The seven members serve staggered 3-year terms.

The DRS has never convened, but must be prepared to meet, if the need arises. PDE has received numerous inquiries about the dispute resolution process and colleges concerned that their fellow TAOC institutions are not implementing statewide articulation in accordance with the legislation or TAOC policy. Before getting PDE or the Dispute Resolution Committee involved, the primary TAOC members at the two institutions involved in the dispute are advised to try and resolve the issue directly. If the issue remains, then the TAOC member who raised the concern should notify PDE (Julie Kane) who will help determine if the issue should be referred to the Dispute Resolution Committee.

The current Dispute Resolution Policy was developed when the transfer system only included Transfer Framework courses. Now that the system has been expanded to include statewide program articulation and transfer of Framework courses by the state-related universities, TAOC needs to review the policy and ask the following questions:

- Does the policy for this committee and process fit the current transfer system?
- Is the process clear?
- Doe it meet our needs?

The Commonwealth authorizes entities to operate as postsecondary institutions through legislation and State Board policies. However, the transfer legislation does not indicate what actions TAOC or PDE should or may take in cases of non-compliance.

In the past, when PDE found an institution to be out of compliance, PDE would notify the TAOC member and institution president in writing of the offense. More often than not, the issue was quickly resolved once it was brought to light and the appropriate people were tasked to correct it.

Members should come to the December 13th TAOC meeting prepared to discuss in more detail. TAOC members with suggested changes should email PDE as soon as possible, if they want those changes included in the December agenda.

9. New Business

Revising Approved P2P Agreements

Barbara Ford (MontCo) said at least three P2P agreements (approved by TAOC in 2011) require the full 30-credit Framework be completed as part of the articulated associate degree. This is causing compliance issues, because the Framework is not a common general education core and the Framework does not include all course options in an institution's general education curriculum.

Julie said there are two ways to address this issue:

- 1. TAOC can expand the Transfer Framework to include more foundation level course titles which TAOC is in the process of doing.
- 2. TAOC members can propose amendments to the agreements.

According to TAOC policy,

Once a statewide program-to-program articulation agreement has been approved by TAOC, no amendments to the agreement can be offered by any party within the initial six (6) months of the agreement. After that time, a TAOC member with a proposed amendment to an approved agreement should submit the change to PDE.



Amendments that seek to alter the substantive nature or intent of the agreement in any part must be forwarded to the appropriate PAC for review and consideration. The PAC will then make a recommendation to the TAOC, and TAOC shall approve or deny the proposed amendments.

As of the October meeting, no one has provided any amendments to PDE. Proposed amendments need to be submitted ASAP, if they are to be reviewed by TAOC at the December meeting.

• List Serve for Individuals Implementing P2P at the Institution Level

Jean Berkeley (Carlow) proposed TAOC establish a list serve or some other vehicle of communication for individuals at the institutions who implementing statewide P2P. PASSHE and the community colleges have affinity groups for registrars, transfer counselors, admissions officers, etc. However, members of Opt-ins also need support.

Tracey Schoolcraft (Ship) will look into setting up a list serve group through the university. Jean offered to assist with leading this effort. If a list serve can be organized, PDE will notify TAOC members with instructions for joining.

• Assessment Subcommittee

Julie asked everyone to confirm the individuals listed on the subcommittee are still able to serve. Any changes should be emailed to PDE. [Note: Appendix C has been revised to reflect updates as of Nov. 19.)

Tom Gregory (Penn College of Tech) is the TAOC chair of the subcommittee. Keith Brown from the National Center for Education Statistics has offered to assist TAOC and the subcommittee with this work. Keith has been instrumental in developing real-time transfer reports in North Carolina.

Once the subcommittee is at capacity, PDE will work with Tom et al to schedule a kick-off meeting.

Appendix D: Overview of Dispute Resolution Subcommittee

Overview

Created by legislation, the Dispute Resolution Subcommittee (DRS) provides a mechanism for resolving institutional disputes that emerge in TAOC or subcommittee deliberations regarding, but not limited to,:

- course equivalency standards
- · courses submitted to meet equivalency standards
- statewide program articulation agreements
- articulated associate degree programs
- parallel bachelor degree programs

If the institution involved in the dispute has made a sincere effort to resolve the dispute but has been unable to do so, the DRS will act in a mediation role, when asked by the institution to do so, in an attempt to reach an outcome satisfactory to all sides.

Responsibilities

The DRS will conduct the following activities:

- 1. Hold meetings as the needed;
- 2. Submit a report to the full TAOC on the specific nature and resolution of disputes as they arise and are resolved, and
- 3. As necessary, bring to the floor of TAOC suggestions and a rationale for changes in the Purpose, Composition, or Operating Policies and Procedures of the Standards Subcommittees.

Membership

The DRS is comprised of a subset of voting members of TAOC.

Membership shall consist of the following:

- 1. The Secretary of Education, or a designee, who shall serve as Chair.
- 2. Three TAOC members representing the Community Colleges.
- 3. Three TAOC members representing the PASSHE institutions.
- 4. One member representing the independent and state-related institutions of higher education that elects to participate in the TAOC.
- 5. Additional members may be added by the Chair of the Subcommittee.

The DRS may also include one member representing the PA Commission for Community Colleges and one member representing the PASSHE Office of the Chancellor.

Members serve a staggered three-year term with rotation by college so that each year one member of the community college sector and one member of the PASSHE sector shall be replaced. The member representing the participating independent institutions of higher education shall serve for three years. Additional members appointed by the chair will serve for a period of three years. If a member is not available to serve at any time during the three year term, the member may assign an alternate representative from their institution or organization.

The rotation by sector is as follows:

 Community Colleges: Montgomery County Community College, Community College of Beaver County, Community College of Philadelphia, Community College of Allegheny County, Northampton Community College, Harrisburg Area Community College, Bucks County Community College, Reading Area Community College, Butler County Community College, Pennsylvania Highlands Community College, Lehigh Carbon Community College, Luzerne County Community College, Delaware County Community College, Westmoreland County Community College Pennsylvania Department of Education Transfer and Articulation Oversight Committee October 25, 2012 Meeting Notes



- *PASSHE:* West Chester University, Shippensburg University, Millersville University, Bloomsburg University, California University of Pennsylvania, Cheyney University, Clarion University, East Stroudsburg University, Edinboro University, Indiana University of Pennsylvania, Kutztown University, Lock Haven University, Mansfield University, Slippery Rock University
- Independent and state-related institutions: Lincoln University (By date that the participation agreement is signed), St. Francis University, Lackawanna College, Pennsylvania College of Technology, Carlow University.

Initial terms of committee members:

- Montgomery County Community College and West Chester University will each serve one year terms, ending June 30, 2009. Community College of Allegheny County and Bloomsburg University will begin a three year term on July 1, 2009.
- Community College of Beaver County and Shippensburg University will each serve two year terms, ending June 30, 2010. Northampton Community College and California University of Pennsylvania will begin a three year term on July 1, 2010.
- Community College of Philadelphia and Millersville University will each serve three year terms, ending June 30, 2011. Harrisburg Area Community College and Cheyney University will begin a three year term on July 1, 2011.

Institutional Dispute Resolution Process

A participating TAOC institution may request a resolution by the DRS to disputes that arise relating to the transfer and application of credits. Contentious issues may include the following:

- A TAOC Curriculum Standards Subcommittee denying a course for transfer as a foundations course;
- A TAOC Curriculum Standards Subcommittee denying a new course title for inclusion on the Transfer Credit Framework; or,
- A TAOC Curriculum Standards Subcommittee approving a course that another institution deems non-transferable.

The Institutional Dispute Resolution Process is as follows:

- 1. The institution submits documentation in writing to the DRS Chair and indicates the details as they relate to the following:
 - a. Specific transfer and application of credits;
 - b. The efforts that the college has made to resolve the dispute; and
 - c. The desired outcome of the dispute resolution.
- 2. Within ten (10) days of receiving the dispute, DRS will decide if it has jurisdiction over the dispute and how to proceed.
 - a. If the issue presented is one of compliance, the DRS will notify the violating institution in writing of the issue and instruct the institution on the problem needs to be corrected to bring the institution back into compliance.
 - b. If the issue does not involve compliance, then the DRS will notify the disputing parties in writing as to the next course of action.
- 3. The DRS Chair notifies the Institution identified in the complaint and requests a response to the complaint within ten (10) business days.
- 4. The DRS Chair schedules a meeting of the Subcommittee within 30 days of receiving the response and sends the dispute specifics and the rebuttal response(s) for review prior to the meeting. Any DRS members identified in the dispute will excuse themselves for that particular case. An alternate TAOC representative may temporarily be appointed to the committee by the



Chair so no less than three community college representatives, three PASSHE representatives, and one independent representative are present at the meeting.

- 5. The DRS Chair convenes the DRS for the purpose of investigating the complaint. When a single location for the meeting is prohibitive, the meeting may be conducted via teleconference. The institution identified in the dispute has a right to be present at the meeting.
- 6. The DRS will propose a resolution to this dispute by consensus within ten (10) days. If a consensus cannot be reached, the DRS Chair will have the responsibility of making the final determination of the resolution. Any determination made will be binding upon the parties.
- 7. The institution and TAOC Curriculum Standards Subcommittee will be notified in writing by PDE as to the final decision and must abide by the final decision.




