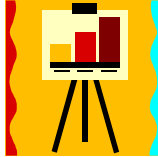
TAOC Updates

- January TAOC Meeting Minutes
- 2010 Annual Report on Transfer and Articulation to the General Assembly

- May 1 – Deadline for institutions to establish course equivalencies w/ Framework courses



Transfer Data Collection & Reporting

- Required by Act 114 of 2006 – Section 2003-C (b)(1)
- Affects all institutions belonging to TAOC
- Analysis of the data will be included in the Annual Report on Transfer and Articulation to the General Assembly



2010 Transfer Data Requirements

- Data for transfer students matriculated in Fall 2010
- Collection will occur in February 2011
- Future data reports will be submitted in accordance with the regularly scheduled end-of-term collections



2010 Transfer Data Requirements

- Institutions participating in PIMS will submit student-level data via PIMS
- Institutions NOT participating in PIMS may submit aggregate data via a PDE-provided reporting template
- Optional fields will be phased in to allow institutions time to modify current practice

Additional Collections in 2010

By July 1, 2010, TAOC members shall electronically submit the following to PDE:

- Summary of articulation agreements as of Fall 2010
- Advising guides that translate the articulation agreements for students/advisors
- Institution credit transfer policy
- Institution transfer student appeals process



Assessing the Transfer Initiative

Act 114 of 2006 requires the Transfer and Articulation Oversight Committee to...

“Develop an assessment/evaluation plan and identify appropriate information and collect appropriate data to ensure the effectiveness of section 2002-C and make necessary revisions thereto over time.”

Assessing the Transfer Initiative

- TAOC Information Technology Development Subcommittee
 - Charged with developing a reporting template for transfer data and selecting an IT solution for transfer initiative/eportal
 - Committee comprised of representatives from CC & PASSHE
 - Inactive since achieving goals
- Reforming subcommittee as the **Information Technology and Assessment Subcommittee**
- **New Charge:** To develop an assessment plan for the transfer and articulation initiative implemented as a result of Act 114 of 2006

Assessment Subcommittee

- Subcommittee will be comprised of:
 - 3 community college representatives
 - 3 PASSHE representatives
 - Appropriate representation from institutions that have formally joined TAOC
 - 1 member from PASSHE
 - 1 member from the PA Commission
- May 1 -- Deadline to submit nominations to PDE
- Subcommittee will form in June

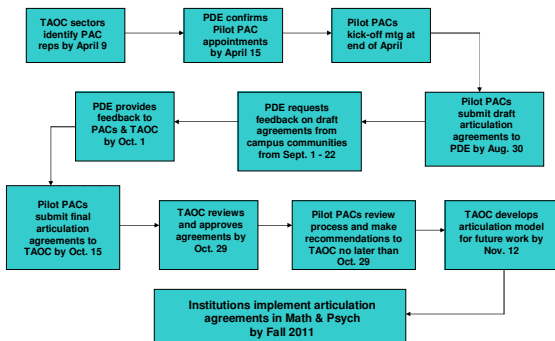
Pilot Program Articulation Committees

Pilot PAC Composition

- **5** CC members (4 teaching faculty from the field of study, 1 non-teaching rep who understands transfer and articulation)
- **5** PASSHE members (4 teaching faculty from the field of study, 1 non-teaching rep who understands transfer and articulation)
- **2** opt-in members (at least 1 teaching faculty member from field of study, 1 rep who may be either faculty or a representative with an understanding of transfer and articulation)
- **1** TAOC member

Pilot Charge & Deliverables

■ **Charge**

- Develop a statewide program-to-program articulation agreement that allows a student to transfer an associate degree in the PACs respective field of study to a participating four-year institution and have at least 60 credits applied toward the graduation requirements of the parallel bachelor degree program.

■ **Deliverables**

- A written program-to-program articulation agreement
- A written report outlining:
 - Approach used to develop articulation agreement
 - Outcome
 - Barriers to success
 - Recommendations for future development of statewide program-to-program articulation agreements

Pilot PAC Milestones

1. Elect co-chairs
2. Develop a project timeline that includes milestones and final deliverables
3. Develop a draft articulation agreement
4. Develop a final articulation agreement and submit to the full TAOC for approval
5. Obtain final approval of the statewide articulation agreements from the full TAOC
6. Submit a final project report that includes the project outcome and recommendations for future statewide program-to-program articulation work.
